The AOSA Communications Director serves as the chair of REVERB and is the official liaison to COMM. The chair of COMM is the official liaison between ECHO and the NBT.

Application Requirements

- At least Level II Orff-Schulwerk training, Level III preferred
- Active member of AOSA
- Writing skills as demonstrated through a sample submission that is suitable for publication in *Reverberations*, previous publication in *Reverberations* preferred

Appointment

Submitted applications are reviewed by the *Reverb* Board with recommendations sent to the Executive Committee of the NBT for approval and appointment by the president.

Term

The term for *Reverb* Board members shall be 3 years with the option to renew for a second 3-year term. Desire to serve again does not guarantee re-appointment. These terms can be changed based on the recommendation of the *Reverb* Board and approval of the AOSA Executive Committee.

Responsibilities

- Solicit articles from AOSA membership.
- Share Reverberations Submission/Writing Guidelines with all potential writers.
- Work with authors to edit writing that is suitable for publication.
- Attend a *Reverberations* Board meeting on the Wednesday afternoon prior to the annual AOSA conference.
- Participate in online meetings as needed during the year (generally 2 meetings).
- Attend and report on meetings at the annual AOSA conference (e.g., President's Panel, Meeting of the Minds) as a shared responsibility with other contributing editors and the *Reverberations* Editor.

Benefits

Fall meeting (1 p.m. to 5 p.m. Wednesday of AOSA conference)
