## **READING OF THE ETHICS STATEMENT**

## **MOTION #2020-19**

The Executive Committee moves to approve the American Orff-Schulwerk Association National Board of Trustees March 31, 2020 Meeting minutes as submitted.

#### Rationale:

The National Board of Trustees of the American Orff-Schulwerk Association met remotely via Zoom March 31, 2020. The minutes submitted for approval reflect the content and events of that meeting effectively and entirely.

## **MOTION #2020-20**

The Professional Development Research Committee moves to award two research grants in the total amount of \$10,735 for the 2020 grant cycle.

#### Rationale:

The two grants awarded qualified for funding for projects related to Orff Schulwerk music education research. Eleven cents more than the annually approved payout is awarded with this motion approving that additional withdrawal from the Research Endowment Fund held at the Cleveland Foundation. This additional withdrawal is still within guidelines of the foundation.

# **Restructuring – Creation of Ad-hoc Committee**

Executive Director Carrie Barnette reviewed points and led a discussion from the two internal documents shared ahead of time which included points from previous small group conversation and shared google docs. The NBT came to consensus agreement. It was decided the Executive Committee would bring forward a formal motion for an electronic vote.

# **NBT COMMITTEE STRUCTURE**

Executive Director Carrie Barnette reviewed points and led a discussion of the internal documents shared ahead of time which included points from previous small group conversation and shared google docs, detailing the proposed committee restructuring. The NBT came to consensus agreement. The Executive Committee will put forward a formal motion for an electronic vote.

#### **UPDATE ON COVID-19 RELATED ITEMS**

Executive Director Carrie Barnette shared information on the following:

• Courses and Chapters

- Noted no traditional courses will be running this summer.
- Noted FAQs regarding COVID cancellations and other issues affecting Chapters has gone out. If further questions arise, Region Representatives are asked to share them with AOSA staff (Anna, Carrie and Debbie) in order to create an updated FAQ.
  - New Chapter Relations committee will be asked to approve recommendations for updating timeline and reporting procedures for Chapters, which will help to disperse the work among several chapter leaders and over a broader time period.
- o New projects being worked on
  - TE videos
    - Noted these will be featured in Reverberation articles (grouped by topic) and several will also be on the public side of the website and then all will be added independently into the Resource Library.
  - PDR packages project
    - Noted these are ready to launch officially June 8<sup>th</sup>. Five are ready now; others are waiting on the uploading of the webliography and some *Orff Echo* articles.
    - Noted we are still working with Ashland University to figure out how to offer college credit combining multiple packages.
  - Mondays With Music Tech, Mondays with Children's Literature PLN Sessions
    - Noted Mondays with Music Tech was a huge success
      - Celebrated 100 250 participants in each session. Information was helpful, practical, and timely.
      - Celebrated "regular AOSA members helping each other". This is helping to create our desired culture.
    - Noted nine weeks of June and July will shift to Mondays with Children's Literature
      - Presenter will share Children's Literature review with Orff applications, entry points they've used with that book and ending with discussion and sharing of other ideas.
      - Three are already scheduled; more to come as people who have been asked or volunteered get slotted in.
- Trial Membership
  - Noted AOSA is officially able to launch the trial memberships in a way that will allow us to track the effectiveness and which groups we have the highest return with
    - Roll out to specific groups over the course of the month of June.
      - First group: those that signed into AOSA portal between its opening and today and didn't join
      - Second group: those registered for courses for summer 2020
      - Third group: posted to FaceBook Discussion Page
      - Fourth group: Chapters, especially those that don't have 100% membership. In this way a chapter could use our Resource Library for a Chapter event.
